- F. UNIT CONSTUCTION: The base fabric shall enclose a polyurethane foam core, which is to be chemically bonded to a roll-formed galvanized steel frame. The cover shall be double hemmed on all edges and fastened to the side leg of the steel framing with Tek screws inserted through load spreading washers. The cover will also include an internal strapping system to keep the cover tightly secured to the core. The unit shall also include full length yellow guide stripes.
- G. WARRANTY: Unit shall include the manufacturers standard (5) year frame warranty and a (1) one year warranty against defects in materials and workmanship on the remaining components.
